

AUSTRIACARD HOLDINGS AG: Major holdings notification pursuant to Sec. 130 to 134 BörseG 2018

Vienna, 24 August 2026

AUSTRIACARD HOLDINGS AG (the "Company") announces, in accordance with § 130 et seq. of the Austrian Stock Exchange Act 2018 (Börsegesetz 2018), that the Company received on 21 August 2026 a notification ("Notification") by the company Dai Nippon Printing Co., Ltd, Tokyo, Japan ("DNP") according to which the participation of DNP in voting rights through financial/other instruments of the Company reached 35.006.835 voting rights representing 96,29% of total voting rights of the Company. According to DNP's Notification, *"On 13 May 2026, Dai Nippon Printing Co., Ltd. filed a notification in connection with an irrevocable commitment relating to 74.58% of the shares with Nikolaos Lykos as seller and Dai Nippon Printing Co., Ltd. as purchaser. Based on information received by Dai Nippon Printing Co., Ltd., in addition to shares tendered in the amount of 0.71% at an earlier time, shareholders representing an additional 21% have tendered their shares as of 20 August 2026. Such purchase is subject to conditions precedent, and settlement will take place in accordance with the terms of the public takeover offer"*. It is further noted that according to the Notification DNP is not controlled by any natural person or legal entity and does not control any other undertaking(s) holding directly or indirectly an interest in the Company.
